## **TERMS & AGREEMENT**

### I. ACKNOWLEDGMENT

All Roommates acknowledge the terms of this Agreement and comply.

#### **II. DURATION**

The following utilities will be covered by the roommates equally: Water, gas, electricity, cable TV, and internet/WiFi VII MAINTENANCE

### VII. MAINTENANCE

The Landlord may enter the premises for the purposes of inspection, repair, maintenance, and emergency.

#### VIII. HOUSE RULES

(a) Roommates shall follow reasonable standards of cleanliness.

(b) The number of guests shall not exceed 8. An overnight guest may not stay for more than two (2) nights.

(c) No roommate shall hold a party or gathering with more than four (4) guests without the written consent of the other roommates.

(d) No roommate shall hold a party in excess of 15 people.

(e) No smoking inside the room or bathroom. The Roommate needs to go to the designated smoking area.

(f) Pets are not allowed on the premises.

#### IX. PEACE AND ORDER

Roommates are not allowed to keep firearms, bows, combat knife and other weapons in the premises. Roommate agrees not to use the premises in a way to disturb the peace and quiet of other tenants.

#### X. AMENDMENTS

This Agreement can only be changed or modified through the written consent of both parties.

#### **XI. GOVERNING LAW**


