Severability - Any provision found in this Agreement shall be held illegal, invalid, or unenforceable by any competent court, the rest of the remaining provisions hereto shall remain valid.

Amendment - No modification or change of this Agreement shall be considered valid unless made in writing and agreed upon by the involved parties.

Governing Law - This Loan Modification Agreement shall be governed by and construed in accordance with the laws of the State of _____.

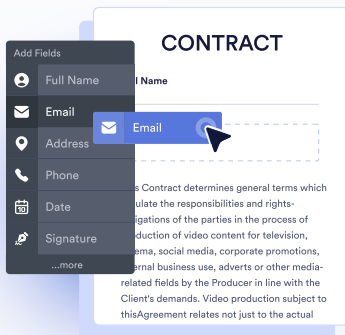

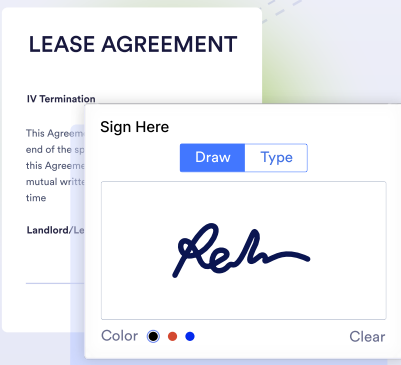
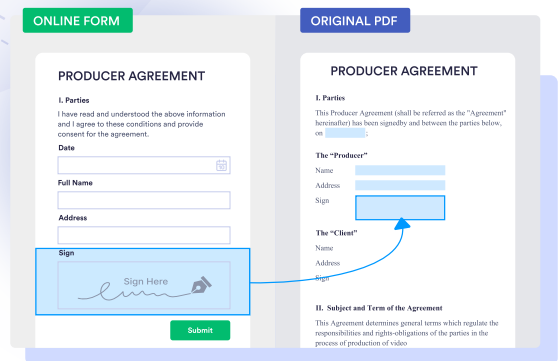
