	the Locker during extended rental periods, the Lessee must have paid the annual rent in advance.			
•	After this Agreement is signed by the parties, the Lessee receives two keys of the Locker, which are			е
	identical to each other and must be returned at the end of the Agreement period, after their			
	suitability for the Locker is checked one-to-one. If one or both of these keys are lost, the Lessee			e
	nust inform the Lessor in writing without delay. The Lessor is not responsible for the consequences			S
	of loss if it does not notified in writing.			

• In case one or both of the keys are lost, the Lessor opens the Locker by a locksmith with the

participation of the Lessee and a new lock is fitted to the Locker. Expenses for breaking and/or

• The Locker can only be used to store securities such as various documents, jewellery, commercial

papers and promissory notes. Weapons, flammable, explosive substances, liquid, smelly and

perishable substances, and substances that would constitute a crime to be possessed or stored by

law cannot be placed in the Locker.

• If necessary, the Lessor has the right to open and check the Locker at any time, with the approval

and supervision of the Lessee or his representative, and to look at the contents of closed packages,

boxes and parcels to be placed in the Locker, as a safety measure.

• If the Lessee does not return the keys to the Lessor within 3 months from the end of the rental

period and does not pay the annual rent in advance, the Lessor is authorized to have

the Locker opened in the presence of a notary public, to take and keep the contents of the Locker in

return for the Lessee's receivables, and to sell these stored contents for the collection of the

receivables.

• Changes regarding the rental fee are published on the Lessor's website. These changes will be valid

from the following period.

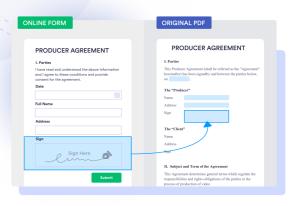

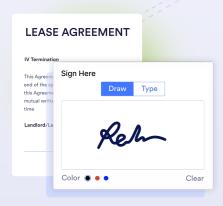
