Safety/Operating Instructions			
Customer is responsible to pick up and return the chair and tables to and from			
Proper care of the chairs and tables during transportation to and from is the sole			
responsibility of the Customer, and any damage that may occur during this process is the sole			
responsibility of the Customer.			
If available, the chairs and tables may. be picked up a day prior to the event and returned the day after			
the event. However, if has been rented for an event requiring the use of chairs			
and tables, that schedule shall be adjusted accordingly. All events taking place at			
shall take precedent over this Rental Agreement.			
Rent Payment			
The Customer agrees to pay% of the total Rent amount as a down payment. The

Returned Check

#### **Inclement Weather and Fortuitous Events**

In case of damage, Customer shall be responsible for an additional cost of the damage incurred except as otherwise damage due to causes of ordinary wear and tear. Customer shall not sublease the rented items to anyone or use the said items in an illegal manner or for illegal purpose.

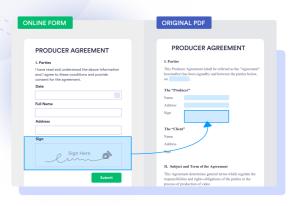
