Terms and Conditions

Scope of Contract

This Vehicle Service Contract ("**Contract**") along with the registration page make up the entire Contract. This Contract outlines the terms and conditions under which the Dealer will provide one-time vehicle services (the "**Service**") for the Customer's vehicle.

This Contract covers only the regular maintenance, defects and anomalies specified on the first page. The Services that are not covered by this Contract are specified separately, and Dealer does not provide these services and does not accept responsibility in this regard.

According to the inspection of the vehicle at the time of delivery, the defects and scratches on the vehicle are as follows and the dealer cannot be held responsible for these damages;

Coverage Details

Coverage

Under this Contract, the services covers scheduled inspection regarding regular maintenance, routine upkeeping, calibration and performance testing services detailed in the first page of this Contract. Replacement of wear-and-tear, proactive replacement of parts subject to natural degradation to avoid unplanned downtime shall also be covered.

All transactions related to labor by skilled technicians are also within the coverage of this Contract.

All necessary materials for routine maintenance and repairs, such as filters, belts, and lubricants, are provided at no additional cost.



Coverage Exception

The following issues are outside the scope of standard service and the Dealer does not make any warranty commitments regarding them;

1. Repainting
2. Hydraulic Clutch Assembly Repair
3. Replacement of hoses and rubber parts
4. Tires
5. Mags
6. Electricals wires and lines (Replacement or Repair)
7. Air Bag
8. Shock absorbers
9. Head Unit, TV, DVD, Phone, Speakers;
10. Break pads and shoes
11. All Vehicle Maintenance items and tune-up service parts such as spark plugs, fuel filters, oil filter, oil and other lubricants, wheel balancing and alignment
12. Belts (fan, timing, etc.) replacement
13. Bulbs
14. Upholstery
15. Breakdown or damage caused by collision, fire, flood, freezing, or those covered by the standard physical damage insurance policies
16. Glass repair/replacement
17. Modifications made that is not the manufacturer's original specifications
18. Damages caused by overheat or negligent use of the vehicle;
19. Any portion or item that is not installed by the manufacturer

Other Terms

Pricing and Payment

The cost of routine services is _____. If there is a part that needs to be replaced in the vehicle or an issue that requires extra expense during maintenance, the Customer will be informed about this along with the cost. Without the written approval of the Customer, the transaction will not be carried out and any costs arising from this cannot be charged to the Customer. All cost and expences shall be paid in advance on the date of delivery of the vehicle to the Customer.



Service Duration

Service duration is determined according to the workload and operations and is notified to the Customer at the time of delivery of the vehicle. Possible delays are immediately notified to the Customer. The delay period cannot exceed _____ hours in routine maintenance.

Warranty

The Dealer guarantees the quality of labor for _____ from the date of service. Replacement parts are covered under the manufacturer’s warranty, and the detailed information and documentation shall be provided to Customer for replaced materials, if any.

Assignment

The Parties shall not assign or transfer this Agreement, or any of their rights or obligations under it, to another party without the prior written consent of the other party. Any attempt to do so without consent shall be void and unenforceable.

Arbitration

Any dispute or controversy arising from this Contract shall be resolved by arbitration, and for which the number of arbitrators or the choice of arbitrator shall be agreed upon by the parties. English shall be the language to be used. The arbitration award shall be based on the facts provided for by both parties. The decision of the arbitrator(s) shall be final and binding upon the parties in the dispute.

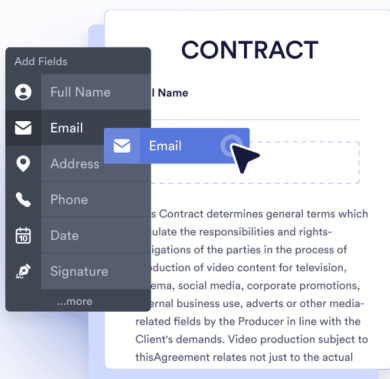

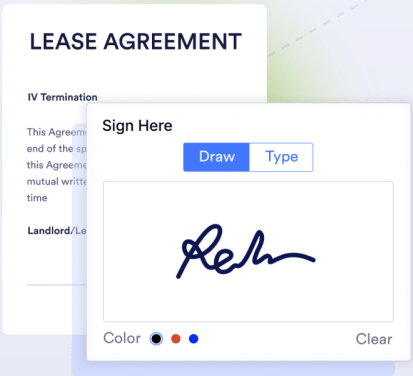
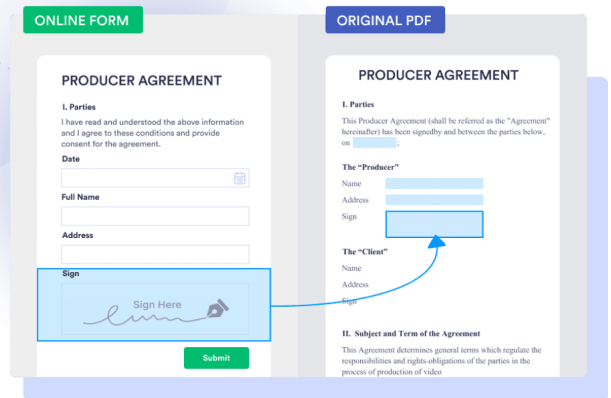
